management presentations, credit analysis.

Evaluate issuer / obligor financial performance, capital structure, credit metrics and critically assess transaction parameters to support term sheet negotiation, pricing, credit analysis and syndication.

Demonstrate sound business analysis skills to assess and articulate business fundamentals, industry positioning, business cycle and growth prospects.

Identify and address key risks during due diligence, transaction structuring, credit approval and documentation stages.

Demonstrate sound understanding of market and business trends and material risk factors that impact credit quality and business / financial conditions; track and communicate relevant market and economic developments

Assist senior team members with project management, coordinate with internal and external stakeholders and provide engagement through the transaction life cycle.
