The role requires strong internal controls (SOX/ICFR) to be able to assess them as part of IPO readiness and to help client remediate control gaps / findings.

The role increasingly requires ESG reporting and Integrated Reporting experience to help companies assess their state of ESG readiness as part of IPO readiness and more broadly as well and to help them with implementing ESG reporting.

Working with colleagues in all Middle Eastern offices on client work and internal initiatives as well as with international teams where appropriate.

Working with PwC teams in the UK/US on capital market transactions involving those jurisdictions.

As a Senior Consultant in the team, the role includes wider practice management responsibilities which will include coaching, competency development and market eminence activities.

Experience with financial modelling would be a plus.

Excellent organisational skills, having the ability to prioritise workload whilst being resilient and being able to cope well under pressure and meeting tight deadlines.

The ability and willingness to travel within the Middle East and worldwide where the project dictates.
